Camp Ooch and Camp Trillium are merging? Yes—in order to reach more families affected by childhood cancer in Ontario, Camp Trillium and Camp Ooch are merging their organizations. The news of our transformational merger was announced on Thursday, September 26, 2019, during National Childhood Cancer Awareness Month.

The primary goal of this historic merger is to create a province-wide camp program that reaches every child and family affected by childhood cancer in Ontario, and enhance the camp and program experience for campers, and their families. Cancer doesn't stop at city or regional boundaries, and now, neither do we!

Why merge now? When will the merger be officially complete?

After careful due diligence, discussions between the two camps, and by the direction of both sets of board leaders, the decision to merge was made to deliver greater impact. This is about two organizations with similar objectives, cultures, and dedicated people coming together to create something better together. We anticipate the two organizations will formally, and administratively, merge in early 2020.

Will camp programs and community-based activities be affected? Not at all—we are moving forward with the merger now, and there will be no changes to either organization's programs for this fall 2019, and winter and summer 2020 seasons, including in-hospital, community and overnight camps. Both camps will continue to do great work for the children and families they serve for many years to come. As we merge, any changes will be communicated when there is information to share.

Will the organization have a new name? And where will the head office be located? At this time, the names of the individual camps will continue, and both camps will continue operating out of their respective head offices.

Will employees still have a job under the new organization? The merger is not about reducing staff or cutting costs—it's about sustaining and expanding programs for children and families affected by cancer. Employees are critically important to this merger. Employees will keep doing the great work they have always done. Management will work together to integrate and grow the organization over time, drawing on the strengths of employees at both Camp Ooch and Camp Trillium.

There are no changes to any of our current programs for this fall 2019, and winter and summer 2020 seasons, and this includes the volunteer program. As we merge, any changes to the application process will be communicated when there is information to share.
